



Non-Domestic Vacant Rating (NDVR) Declaration Guidance Notes

A property is considered vacant for rating purposes if it is unoccupied, unfurnished and not used for storage.

Vacant rates are not payable for a property with a Net Annual Value (NAV) of less than £2,000.

For properties with a NAV of £2,000 or more, rates are not payable for three months from either the date on which a non-domestic property becomes vacant or, in the case of a property which has never been occupied such as a new build, the date on which Land & Property Services (LPS) has determined the property to be completed.

After the three month period has ended, rates will be assessed at 50 per cent of the normal occupied amount until the property becomes occupied. Please note the property must be occupied for a minimum of six weeks before there is an entitlement to another three month free period.

NOTES

- This Declaration must be used by the person entitled to possession of a non-domestic property (i.e. either the owner or leaseholder) to inform LPS of a vacancy.
- You must complete all questions and enter all required information unless directed otherwise.
- For rating purposes a property is considered vacant if it is:
 - · Unoccupied,
 - · Unfurnished; and
 - · Not used for storage.
- You must complete a separate Declaration for each property for which you wish to declare a vacancy.
- To declare multiple properties as vacant, please email rating@lpsni.gov.uk. You must include all the information requested on this form for every property you wish to declare as vacant.
- All information you supply must be true and accurate.
- You must provide all necessary information and documentation to support your vacancy Declaration. If you do not supply this information, LPS will not be able to process your Declaration.
- You must continue to pay your rate account while your Declaration is being considered.

Data Protection

Please be aware that LPS or an agent acting on its behalf may carry out an inspection of the property to confirm that it is unoccupied, unfurnished and not used for storage purses. If the property is found to be occupied or used an occupied rate bill will be issued.

LPS carries out periodic reviews of vacant properties. You may be required to produce evidence that the property was empty and unused whilst declared as vacant. Failure to do so will result in NDVR Relief being withdrawn and the issue of an occupied rate bill.
